This declaration made on the Twenty first day of January, Year Two Thousand and Four, by and between:

1. REV SAMUEL MATHEW, aged 44, son of Mr. K. M. Mathai, occupation Evengelst, residing at Kaithapthailil House, Cherukole Muri, Gherukole Village, Ranni Taluk, Pathanamthitta District (hereinafter referred to as the party of the first part)
2. REV. JACOB. T. ANTONY, aged 52, son of Late T. V. Antony, occupation Evangelist, residing at Thottuvellil House, Aayparambu Muri, Cheruthana Village, Karthikappally Taluk, Alleppey District (herein after referred to as the party of the second part)
3. His Grace MOST REV. DR. K. P. YOHANNAN, aged 53, son of Late Chacko Punnoose, occupation Evangelist, residing at Kadappilari House, Mannamthottuvazhi Padijattumuri, Niranam Village, Thiruvalla Taluk, Pathanamthitta District (hereinafter referred to as the party of the third part)


WHEREAS the parties of the first four parts alongwith one Shri. K. C. Punnoose, son of K. P. Chacko had subscribed to among themselves a sum of Rs.500/- (Rupees five hundred only) on the twenty fourth day of March, Nineteen Ninety three and executed a trust deed (hereinafter referred to as the original trust deed) forming a public religious trust under the name " Believers Church India ", Thiruvalla (hereinafter referred to as the Church and / or trust) with a view to the same being applied in trust according to their discretion in creating, establishing and endowing for the objects specified in the said trust deed registered as document number 124 in Book IV of 1993 with Thiruvalla Sub Registry.




AND WHEREAS the parties of the first four parts had on the fifteenth day of January. Two thousand two (15-01-2002) executed a supplementary deed which was registered as number 70 in Book IV of 2002 with Thiruvalla Sub Registry (hereinafter referred to as supplementary deed number one), which, interalia brought on record the removal of Shri. K. C. Punnoose from the trusteeship of the trust with effect from the first of January 1998 while inducting three persons namely one Mr. Varghese Jacob son of Mr. Koshy, one Rev. Babykutty Lukose, son of G. Lukose and one Rev. T. P. Thomas, son of Pappy as additional trustees. AND WHEREAS through the supplementary deed number one, the objects of the trust were also restated for better clarity while elucidating the object clause (I) of para nine of original trust deed, so as to, better reflect the intention of the founders / settlers, while correcting the error in the name of the trust which was shown in the original trust deed as 'Believers Church in India' instead of 'Believers Church India'.


AND WHEREAS the trustees have now received resignations of Rev. Babykutty Lukose, Rev. T. P. Thomas and Mr. Varghese Jacob from the Board of Trustees and have unanimously decided to accept these resignations.


AND WHEREAS the trustees now find it necessary to induct three more persons as additional trustees to the Board of trustees, for the efficient and effective functioning of the trust. AND WHEREAS trustees of the fifth to seventh parts namely Rev. Juria Bardhan, Rev. Ebenezer Samuel, Mr. Christy K. Cheriyan have desired to become additional trustees, by contributing Rs.1000/- (Rupees one thousand only) each totaling to Rs. 3,000/- (Rupees three thousand only) to the corpus of the trust. AND WHEREAS the trustees find them to be eminently eligible to become additional trustees and are willing to induct them so. AND WHEREAS each parties of the, fifth, sixth and seventh part have already together contributed Rs.3,000/- (Rupees three thousand only) in consideration of them being admitted as additional trustees, to hold trusteeship in accordance with the terms of this deed.



AND WHEREAS the trustees also find it necessary to clearly specify that the Church has been unanimously resolved and declared by the General Assembly to be a Biblical Episcopal Church in its system of governance. AND WHEREAS the trustees also find necessary to declare the factum of Believers Church India being a Biblical Episcopal Church with all the rights and privileges granted therein to Episcopal Churches under the Indian Christian Marriage Act 1872, (Act No. XV of 1872) available to its Metropolitan Bishop and subsequently under the endorsement of the Metropolitan Bishop to the duly consecrated Bishops of the Church, including power to issue marriage license to the Presbyters / Pastors of the Church in accordance with the Indian Christian Marriage Act 1872, and in accordance with the marriage policy of the Church.

AND WHEREAS the trustees also find it necessary to reaffirm that Believers Church India had and are following the doctrine of Biblical and Evangelical faith, which it had followed right from its inception, with the Metropolitan Bishop being the constitutional head, having ample room for Evangelism and Episcopal Church governance in its constitution in word and spirit. AND WHEREAS the trustees have also resolved that the Believers Church shall take the name of the country irrespective of national and political boundaries.

AND WHEREAS the trustees find it necessary to produce in writing all the above as well as related matters and have it registered under the Indian Registration Act 1908 with Sub Registry, Thiruvalla.

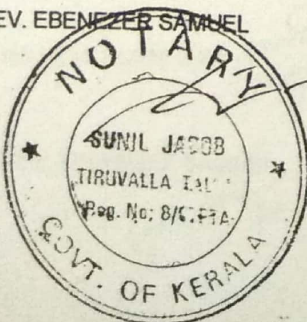

NOW THIS DECLARATION WITNESSETH AS FOLLOWS :

1. The name of the trust shall continue to be BELIEVERS CHURCH INDIA.
2. The trustees take on record the resignation of three of the trustees namely, Rev. Babykutty Lukose, Rev. T. P. Thomas and Mr. Varghese Jacob from the Board of Trustees.
3. Rev. Juria Bardhan, Rev. Ebenezer Samuel, Mr. Christy K Cheriyan trustees of the fifth, sixth and seventh parts are hereby inducted as additional trustees of the trust under the power vested in the existing trustees vide clause Seven of the original trust deed and they shall have all the powers of a trustee, subject to other clauses of original trust deed and supplementary deed number one, and shall hold properties of the trust jointly, alongwith other members of the Board of trustees, till they are removed from their offices or retire by rotation or resigns or demits the office for any reason whatsoever. With the induction of Rev. Juria Bardhan, Rev. Ebenezer Samuel, Mr. Christy K Cheriyan as additional trustees, the Board of trustees at present comprise of the following persons:

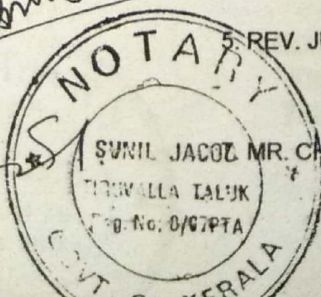
4. The objects of the trust shall continue to be to the same, as stated in the original trust deed and further elaborated in the supplementary deed number one.





5. This trust will continue to be a public religious and charitable trust that include in its fold a wide section of the Public as its beneficiaries.
6. It is hereby declared that Believers Church India is a ~~Biblical- Episcopal Church in its system of~~ Church governance, as decided unanimously by the General Assembly of the Believers Church India, held at Nagpur on thirteenth December Two thousand two(13-12-2002).
7. Believers Church India will strictly follow the provisions prescribed in The Indian Christian Marriage Act 1872 (Act No.XV of 1872), as well as the marriage policies of the Church that are applicable for the Episcopal Churches with immediate effect. . The Metropolitan Bishop and subsequently under the endorsement of the Metropolitan Bishop, the duly consecrated Bishops of the Believers Church, irrespective of country where they belong, be and are authorized to issue marriage license to the Presbyters/Pastors of the Church as per the prevailing law of the land. This also applies in administering the Church ordinances and sacraments as per the constitutional provisions of the Church.
8. The Church hereby reaffirm the doctrine of Biblical and Evangelical Faith, which it has followed right from its inception based on divine revelation recorded in the Holy Bible.
9. Since the Church is universal, irrespective of its geographical, political and national boundaries, whichever country it is, it may be known as Believers Church of that country appended last to Believers Church. Nevertheless wherever the name Believers Church is used, it shall mean and only mean this Church.



Believers Church hereby affirms and declares that the Metropolitan Bishop is the constitutional head of the Church universally, irrespective of the country where it is, and it also gives ample rooms for evangelism and the Episcopal Church government and Episcopal system of governance in its constitution, in word and spirit. As constitutional and ecclesiastical head, His Grace, the Metropolitan Bishop will be the supreme authority of the Church and will hold the final word on all matters whether concerning policies or theological beliefs and activities of the Church.
11. Except for the changes, alterations, additions and corrections made through this amendment deed, all the clauses of the original trust deed registered as number 124 in Book IV of 1993 with Tiruvalla Sub-Registry, as modified / elaborated / altered by the first supplementary deed registered as number 70 in Book IV of 2002, with Tiruvalla Sub-Registry shall continue to be in force.
12. This deed is to be registered in Tiruvalla Sub Registry, and is signed at Tiruvalla at premises number XI / 645 of Thiruvalla Municipality.


